#### A Summary of Your Rights Under the Fair Credit Reporting Act

The federal Fair Credit Reporting Act (FCRA) promotes the accuracy, fairness, and privacy of information in the files of consumer reporting agencies. There are many types of consumer reporting agencies, including credit bureaus and specialty agencies (such as agencies that sell information about check writing histories, medical records, and rental history records). - **You must be told if information in your file has been used against you.** Anyone who uses a credit report or another type of consumer report to deny your application for credit, insurance, or employment – or to take another adverse action against you – must tell you, and must give you the name, address, and phone number of the agency that provided the information.
- **You have the right to know what is in your file.** You may request and obtain all the information about you in the files of a consumer reporting agency (your "file disclosure"). You will be required to provide proper identification, which may include your Social Security number. In many cases, the disclosure will be free. You are entitled to a free file disclosure if:
  - a person has taken adverse action against you because of information in your credit report;

Reviewing the account includes activities related to account maintenance, monitoring, credit line increases, and account upgrades and enhancements.

- **You may seek damages from violators.** If a consumer reporting agency, or, in some cases, a user of consumer reports or a furnisher of information to a consumer reporting agency violates the FCRA, you may be able to sue in state or federal court.

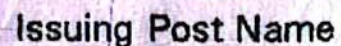

the Internal Revenue Code, federal, state, local or foreign tax laws and regulations. Any payments made in instalments shall each be treated as a separate payment for purposes of Treasury Regulation Sec. 1.409A-2(b) (2) and you may not designate the calendar year of any payment.

Upon joining the Company as an employee, you will be subject to the Company's policies and procedures applicable to all personnel of the Company, including, if applicable, the North America Wholesale Securities License and Examination Policy, found on the Company's intranet. Upon acceptance of this offer and at orientation, you will be provided with this information and training on certain policies and procedures and will be expected to familiarize yourself and comply with those and all other policies and procedures of the Company applicable to you. **Non-Solicitation of Employees**

Nor will you, during your employment or during the period referred to above, directly or indirectly encourage or induce any employee of the Company or its affiliates to leave the employ of the Company or its affiliates.

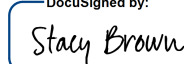

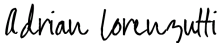
