KNOW ALL PERSONS BY THESE PRESENTS,

WHEREAS, the Principal has by written agreement entered into a Lease/Rental Agreement (the "Contract") with the Landlord for the lease of 626 1st Avenue, Apt E.04E, New York, NY 10016 from on or about June 25, 2026 to June 24, 2027 for the rental sum of seven thousand, four hundred seventy-one dollars (\$7,471.21) per month.

WHEREAS, the Principal has by written agreement entered into a Lease/Rental Agreement (the "Contract") with the Landlord for the lease of 626 1st Avenue, Apt E.04E, New York, NY 10016 from on or about June 25, 2026 to the earlier of, the final expiration date of the lease and renewal leases signed thereafter; the lease termination date as agreed upon by the Principal and Landlord at the time of or after the signing of the initial Lease, the date the Principal has surrendered possession of the apartment, under the Contract for the security deposit amount of seven thousand, four hundred seventy-one dollars (\$7,471.21).

NOW, THEREFORE, THE CONDITION OF THIS OBLIGATION IS SUCH, THAT if the Principal shall promptly and faithfully perform the Contract with the Landlord and pay all lease/rental charges thereunder; then this obligation shall be null and void; otherwise it shall remain in full force and effect.

1. Whenever the Principal shall be, and declared by the Landlord to be in default under the Contract, the Landlord having performed the Landlord's obligations thereunder and having complied with the Bond General Terms and Conditions and Program Agreement if such Program Agreement has been executed.
